FEDERAL ELECTION LAW COMPLIANCE

- By checking this box, I confirm that the following statements are true and accurate.
- I am a United States citizen or a permanent alien.
 - I am making this contribution from my own funds, and not those of another.
 - I am making this contribution on my personal credit or debit card and not with a corporate or business credit or debit card or a credit or debit card issued to anyone else.
 - I am at least 18 years of age.

No corporate checks, including professional corporations (P.C. or P.A.), may be accepted. Partnership checks are welcome, including LLCs. Unincorporated partners, who are not foreign nationals, must provide, with their contribution, a written statement listing the names of the contributing partners and the amount to be attributed to each. Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation and name of employer of individuals whose contributions exceed \$200 in an election cycle. Contributions are not considered charitable contributions for federal income tax purposes. Joint contributions may be written on an account on which only one spouse draws as long as both spouses sign the check or sign this card where indicated. Campaigns may not accept contributions from foreign nationals defined as follows: 1. not a citizen of the United States 2. not lawfully admitted for permanent residence or 3. a foreign principal.
 NOTE: An immigrant is eligible to make a contribution if the immigrant has a "green card". Individuals who are under 18 years of age are prohibited from making contributions to federal candidates.
